Dear Owner:

Between 2005 and 2007, the Wheatlands Metropolitan District ("District") financed the installation of the water lines, sewer lines, streets, sidewalks, streetscapes, medians, irrigation, landscaping, parks, open space, the clubhouse, clubhouse parking lot, and pool serving the Wheatlands' Community (the "Public Improvements").

After the Public Improvements were completed, the water lines, sewer lines and streets were turned over to Aurora for operation and maintenance. In addition, the District and Wheatlands Master Homeowners Association (the "HOA") entered in to a Management Agreement wherein the Association agreed to operate and maintain the clubhouse, pool, clubhouse parking lot and landscaping *immediately adjacent* to the clubhouse. The District continued to be responsible for the remainder of the Public Improvements (landscaping, parks and play areas) not turned over to Aurora or being maintained by the HOA.

In order to better manage and more efficiently and effectively operate and maintain the landscaping, park and play areas, the District hired a new landscape maintenance contractor in the fall of 2010, at a savings of approximately \$50,000. In addition, the District and the Association terminated the Management Agreement in the summer of 2011, and the District started managing the clubhouse, pool, associated landscaping, and clubhouse parking lot, in addition to the landscaping, parks and play areas it was already maintaining.

The current breakdown of services provided, as well as the associated fee, is as follows:

Metro District - \$50 per month (2011) (exclusive of taxes)

HOA - \$30 per month (2011)

Landscaping throughout community (red areas on map) Clubhouse Pool (Lifeguards for 2012 season) Parks/Playgrounds Snow Removal (common area sidewalks) Entry Monuments Website (coming soon) Covenant Enforcement Architectural Review Trash removal

In an effort to provide additional cost savings, more transparency, and consolidated management of the Wheatlands' Community, the District and HOA are proposing to amend the current Declaration to allow the District to provide covenant enforcement, architectural review, and trash removal. The HOA will then be dissolved.

Additional benefits include:

- District will assume all duties and functions of the HOA at a reduced cost (from a combined \$80 per month to \$60 per month assessment for 2012).
- Duplicative management and administrative costs will be eliminated.
- Community resident will have a single point of contact for questions and concerns.
- More efficient and less costly collection of assessments.
